PAYMENT OF DUTY BILL/REIMBURSABLE BILL/MISC. BILL PAYMENTS: I RECEIVED AN EMAIL THIS MORNING FROM ATLANTA CBP. IT SEEMS THAT THE PORT OF ATLANTA HAS BEEN RECEIVING A LOT OF BILL PAYMENTS SENT OVERNIGHT TO THE PORT OFFICE. THEY IN TURN HAVE TO FORWARD THE PAYMENT TO THE **BANK OF AMERICA LOCKBOX** RESULTING IN FURTHER DELAY OF THE PROCESS OF THE PAYMENTS. THE PORT HAS ASKED THAT WE MAKE SURE OUR LOCAL BROKERS AND IMPORTERS HAVE THE CORRECT OVERNIGHT ADDRESS FOR BILL PAYMENTS. THE DATE OF PROCESS COULD DETERMINE WHETHER INTEREST IS DUE.

BILL PAYMENTS: U.S. CUSTOMS AND BORDER PROTECTION (CBP) UTILIZES A **LOCKBOX FACILITY AT THE BANK OF AMERICA IN ATLANTA, GEORGIA**, TO RECEIVE, PROCESS AND POST MOST BILL PAYMENTS. WHEN CBP GENERATES A BILL, THE ADDRESS WHERE PAYMENT SHOULD BE SENT IS PRINTED ON THE ACTUAL CBP BILL FORM (CF 6084). ACCORDINGLY, IT IS IMPORTANT THAT PAYMENTS ARE SENT TO THE CORRECT ADDRESS.
